REPORT ON THE 2025 AUCTION OF HAY & STRAW



The 64th Thimbleby & Shorland/Adkin Annual Sale of Hay & Straw was held live and online again this year with more prospective buyers registered online than were in the room. A larger entry of about 1500 tonnes was on offer compared to the previous year. The market for straw was strong, due to the difficult conditions at harvest. This reflected in a 100% clearance of both wheat and barley straw. With an average of £83/tonne for barley straw and £62/tonne for wheat straw. Whilst there is plenty of fodder about, much is of average quality. This reflected in a clearance of just 34% and averaged out at £70/tonne.

There was no trade for haylage. Thanks go to all parties for continuing to support the sale, and to those newer vendors.

Principal prices achieved were:

HAY

Meadow Big Bales Top price Claas 2200 bales £30 per bale (approximately £75/tonne) (Dave Skardon). Average approx. £70/tonne. 34% clearance.

STRAW

Wheat Top price Claas Quadrant 3200 bales £29 per bale (approx. £87/tonne) (Delafield Brothers). Average approx. £62/tonne. 100% clearance.

Barley Top price Claas Quadrant 3200 bales £31.50 per bale (approx. £94/tonne) (Delafield Brothers). Average approx. £83/tonne. 100% clearance.

CAPITAL GRANTS ON HOLD

On the 28th of November, after increasing speculation, the Rural Payments Agency (RPA) announced that the Capital Grant Scheme would be temporarily closed until early 2025.

The RPA explained that there had been "unprecedented demand" for capital items both in respect of the value of items applied for and the volume of applications received. Applications made ahead of this date have been put on hold and applicants will be informed whether they will be offered an agreement although the RPA has not fixed a date by which to do this, only referring again to "early 2025". Clients should keep a close eye on their inbox for any updates and refrain from purchasing any items they applied for as not to make any potential future agreement ineligible should they be offered one in the coming weeks.



ENGLAND RIGHTS OF WAY REGISTRATION DEADLINE REMOVED

The Government has announced that the 2031 deadline to register English public rights of way on the definitive map will be removed. The Countryside and Rights of Way Act 2000 brought a deadline of 1st January 2026 to register lost and forgotten routes that, evidence providing, were once public highways, however this deadline was extended to 1st January 2031 following a Local Authority backlog. This latest development will remove this cut-off date entirely once the legislation is passed to do so, leaving landowners uncertain whether rights of way registrations will concern them in future.



The CLA has responded and called this announcement the "latest attack on the countryside", arguing that campaigners have already had plenty of time to record rights of way.

A proactive approach is necessary to prevent usage of private routes, such as erecting clear signage, installing or repairing fencing and gates and importantly evidencing such measures by photographing them in place should a future registration be made.

DEFRA AT THE OXFORD FARMING CONFERENCE



On Thursday 9 January, DEFRA secretary Steve Reed spoke at the annual Oxford Farming Conference amidst the sounding of tractor horns from farmers outside protesting against the reforms of Inheritance Tax Agricultural Property Relief (APR) announced in last years' autumn budget.

Steve Reed acknowledged the challenges farmers face including extreme weather events, disrupted imports/exports due to Brexit and increasing input costs. He commented that food production and environmental objectives must work together to achieve long term food security with his "New Deal for Farmers" covering the following:

- Working alongside Angela Rayner to deliver planning reforms, allowing greater diversification opportunities
- New policies to allow farmers to sell their own renewable energy
- A local food procurement target of 50% for food consumed in hospitals, prisons and army bases
- Protection for British farmers in international trade deals
- Flood defence funding review
- Improving innovation through the Accelerating Development of Practices and Technologies (ADOPT) grant programme.

Steve Reed revealed that 50% of farms in England have signed up to the Sustainable Farming Incentive scheme. He also apologised for the "shock" the APR reforms brought after the budget but not for the decision itself, referring to Labour's inheritance of a "£22bn black hole in public finances". Overall, his speech was overshadowed by the elephant in the room of the APR announcement and it was difficult to believe his insistence that he listened to farmers.
